

1. Introduction

Bradford Engineering BV (BE) is a company that specializes in the development, manufacture and supply of subsystems and components for the commercial and institutional space market. On November 3rd 2016 the organization became part of the American Industrial Acquisition Corporation (AIAC) group. The EU General Data Protection Regulation (GDPR) was designed to harmonize data privacy laws across Europe, to protect and empower all EU citizens' data privacy and to reshape the way organizations across the region approach data privacy. Your trust and confidence are important to us, therefore, we provide information on how we collect, use and share your information. Our collection, use and sharing of your information is only based on your permission or where allowed by law.

2. Content

We are committed to safeguarding the privacy of our website visitors and customers. This policy applies where we are acting as a data controller with respect to the personal data of our website visitors and customers, in other words, where we determine the purposes and means of the processing of that personal data. BE appreciates your interest in the company and your visit to the company website. Your privacy is important to us and we want you to feel safe when using this website. BE strives to offer Internet services that do not compromise the privacy of customers and visitors. BE does not collect any personal data from visitors to the website, if not actively contacting us via any of the email addresses or phone numbers provided on the website. In the cases of above, only a handful of our employees have access to personal data you might leave with us. BE does not keep personal data longer than necessary. When personal data is no longer required, it is deleted. This applies, for example, when a question has been answered or when a contractual relationship has been terminated and the parties' transactions are finalized. However, in certain special cases, the data may need to be saved for statistics or accounting purposes, for example.

3. GDPR compliance

BE is committed to comply with its obligations related to the General Data Protection Regulation (GDPR) law. The steps we have taken include: keeping personal data up to date, by storing and destroying it securely, by not collecting or retaining excessive amounts of data, by protecting personal data from loss, misuse, unauthorized access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data. In accordance with the GDPR, we are required to identify and evidence the lawful basis by which we collect your personal data.

4. Cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences. The site www.bradford-space.com itself collects no cookies, all cookies are stored by local browser settings.

5. Data Security

Bradford Engineering BV has electronic and administrative security processes in place in our facilities to protect against the loss, misuse, unauthorized access, or alteration of information. Despite this, the transmission of information via the internet is not completely secure and we cannot guarantee the security of your personal information transmitted to our site; any transmission is at your own risk. We do not accept liability for any interception of your personal information that may occur.

6. Data Protection Officer (DPO)

The new European Privacy Regulation (the General Data Protection Regulation) requires a Data Protection Officer in the organization only in the case of processing personal data on a large scale due to its nature or size. Bradford Engineering BV is for this reason not obliged to appoint a DPO / FG. For more information about the privacy rules of BE please contact us via e-mail (article 12).

7. Third parties

Bradford Engineering BV will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law to do so. Under the GDPR, BE may only work with data processors that meet the requirements of the GDPR and ensure the protection of the rights of the data subjects. The recitals specify that the guarantees to be provided relate to expert knowledge, reliability and resources. Data controllers are obliged to enter into a written contract, or other binding legal act under EU or Member State law, with each data processor.

8. Acceptable usage

You may only use our website for lawful purposes and not for any activity that breaches any law, either local, national or international, or is in any way abusive or damaging. If BE determines that there is evidence or suspect of a breach, we may use your personal data to take appropriate actions that could potentially result in legal proceedings and actions against you. If you wish to correct and/or update information you can notify us of this change by contacting Bradford Engineering BV. You may, where permitted by GDPR, submit a Subject Access Request to Bradford Engineering BV to check whether we hold your personal information, require Bradford Engineering BV to provide you with a copy of your personal information and require Bradford Engineering BV to correct or delete or restrict the processing of any of your personal information that is inaccurate or that you don't want us to hold. This request should be made in writing to our contact address (article 12).

9. Complaints

If you wish to complain to Bradford Engineering BV about how your personal information has been processed, you may lodge your complaints directly by email or in writing (article 12).
